ORDINANCE NO. 22 -02

AN ORDINANCE VACATING ALLEY

WHEREAS, a Petition to vacate the section of the alley right-of-way as described in the legal description attached hereto as Exhibit A was made to the Village of New Madison;

WHEREAS, this Council is satisfied that there is good cause for such vacation and that the vacation will not be detrimental to the general interest of the Village of New Madison or its citizens.

NOW, THEREFORE, VILLAGE OF NEW MADISON HEREBY ORDAINS, at least four (4) members of the Village Council concurring, that:

Section 1. This Council finds that the Petition to vacate a section of the alley right-of-way described in the attached Exhibit A, has been properly presented to this Council.

Section 2. This Council further finds that there is good cause for such vacation and that such vacation will not be detrimental to the general interests of the Village of New Madison or its citizens and ought to be made.

Section 3. It is hereby declared that the alley right-of-way described in Exhibit A, is vacated.

Section 4. Based upon the signed waiver and consent of the only other abutting property owner, the entire interest in the shall be transferred to Dora J. Waymire, subject to all existing legal easements of record.

Section 5. The Village Mayor is hereby instructed to undertake any necessary endorsements upon the Vacation Plat that are needed to show the action of this Council in vacating the above-referenced alley, and to cause a certified copy of this Ordinance and the Vacation Plat to be recorded in the office of the Recorder of Darke County, Ohio. The Village Clerk is further directed to notify the Auditor of Darke County of the vacation by sending her a copy of this Ordinance.

Section 6. It is found that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

0.059 Acre Tract Vacation of Alley

thence North 34°29'40" West 155.74 feet to a point at the northeast corner of Lot 45;
