Public: Scoob Cook – Fire Chief reported on the campaign to build a training center in Darke County costing approximately a million dollars and asking for donations through GoFundMe or PayPal.

Mayor: 4th of July Committee will be paying for security/policing during the celebration. **Village Admin**: Pickleball court finished by Seamless; striping and net will be done. Fire hydrants painted. Recommend hiring Jayden Hollinger as part-time summer help. **Solicitor**:

Fiscal Officer: 2021-2022 financial audit is finishing up. Pro One Painting submitted a quote \$6,677.85 to paint the Admin building. Copier lease with Loudy's – updating the copier at the same monthly amount of \$130.00 with no maintenance agreement. On the last agreement the village saved of \$5,050.00 on copier expense. Farmer motioned to suspend the rules and ready by title 2nd and 3rd time Resolution 23-11increasing appropriations and expenses for 2021 State Highway Fund; second by Lawrence.Yea – Farmer, Lawrence, Cook, Schlechty, Begoon, BrunerMotion passedFarmer motioned to adopt Resolution 23-11; second by Cook. Yea – Farmer, Lawrence, Cook,Schlechty, Begoon, BrunerMotion passed

Unfinished Business: Begoon addressed the request from Brian Anderson to reduce his sewer EDU's for the grocery and mini-mart. Utility clerk and Sewage Sanitation & Water Committee reviewed 10 years of usage for the grocery and mini-mart. They are using water for 2 EDU's of sewage and almost 3. Committee is recommending the grocery and mini-mart remain at 2 EDU's. Sewage Sanitation & Water Committee is recommending an increase of 10 EDU's for the school and 1 for Schlechty's Sports Bar & Grill as their water usage is above the current charges. Begoon motioned to raise the EDU's for Tri-Village Schools to 30 and Schlechty's Sports Bar and Grill to 3.5; second by Lawrence. Yea – Farmer, Lawrence, Cook, Begoon, Bruner Abstain - Schlechty Motion passed

Brice Schmitmeyer spoke on the Wastewater Plant Upgrade/Wayne Lakes Project. Bids for Wastewater Treatment Plant upgrades came in 1.2 million over original estimate. Darke County Commissioners have been asked if they would be willing to contribute \$600,000.00 as a buy-in towards Ft. Jefferson to assist with this project. New Madison will take on the additional debt with the county paying an annual payment towards the debt. Ft. Jefferson will begin 2024 joining with Wayne Lakes in the sewer project. Wayne Lakes is under construction. Waiting on commissioners to vote, a contract with Darke County and resolution before approval of the Jutte Excavating bid. Wayne Lakes has received an additional 3 million grant and would like to use towards extending line to plant instead of the force main at the north side of New Madison. Flow meter will monitor Wayne Lakes waste.

New Business: Wayne Street vacant lot overgrown with weeds. Mayor Schlechty will send letter.

Access Engineering has preliminary plans for drive to new water tower.

Lawrence motioned to adjourn at 6:50 p.m.; second by Begoon. Meeting adjourned
