RESOLUTION NO. 23-13

A RESOLUTION TO CERTIFY DELINQUENT UTILITY CHARGES TO THE DARKE COUNTY AUDITOR FOR PLACEMENT ON REAL PROPERTY TAX LIST AND DUPLICATE AND DECLARING AN EMERGENCY

WHEREAS, certain property owners in the Village of New Madison, Ohio, have delinquent utility bills and all attempts to collect these outstanding amounts have been unsuccessful; and

WHEREAS, pursuant to the Ohio Revised Code Section 743.04, it is necessary to collect these delinquent water, sewer, trash, and storm drainage bills by certifying these amounts to the Auditor of Darke County, State of Ohio, for placement on Darke County's tax duplicate, along with the interest and penalties allowed by law; and

WHEREAS, a list of the property owners, their addresses with parcel identification numbers, and the amounts unpaid are incorporated by reference and marked as EXHIBIT "A" in this Resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of New Madison, Darke County, Ohio:

SECTION ONE. The property owners who have delinquent amounts of water, sewer, trash, and storm drainage bills are identified in the list marked and attached to this Resolution as EXHIBIT "A". The list of property owners and their property as identified in EXHIBIT "A" shall be certified by the Clerk of this Council to the Auditor of Darke County, State of Ohio, to be placed by her on the Tax Duplicate and collected as other taxes are collected, according to Law, including interest and penalties. Payments received by the Village of New Madison prior to August 31, 2023 at 4:00 p.m., the close of business, shall not be certified, but removed from this list.

SECTION TWO. The Council finds and determines that all formal actions of the Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION THREE. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Resolution is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
